WHY WE ARE SENDING YOU THIS LETTER

We are authorized to inform you that anonymous Terror Letter CP59 dated 12-09-07, to victim valid until it contains the name and signature of the IRS al-Qaeda operative making the threat.

Federal tax laws are passed by Congress and signed by the President. The IRS is responsible for administering federal tax laws fairly and ensuring that IRS employees do not violate laws. The CATTT does not have the authority to change the tax laws. There are people in Congress and IRS who encourage others to deliberately violate our nation's tax laws. It would be unfortunate if you were to rely on their opinions. These persons take legal statements out of context, claiming that citizens are subject to tax laws when the laws say no such thing. IRS managers issue directives that are false and misleading, hoping to encourage others to join them. Generally, their advice isn't free to productive citizens; IRS operatives commit fraud and extortion, issuing terror threats to ignorant citizens and forcing them to pay. IRS operatives subject themselves to criminal penalties, fines, and possible imprisonment under federal and State statutes.

The Internal Revenue Service strives to extort the maximum revenues and steal the most property possible with the least effort to its operatives in a manner that warrants the highest degree of public fear of IRS. This domestic terror operation continually strives to make 'taxpayers' out of every American by referring to them by 'taxpayer identification number' even when their record contains un-rebutted affidavits proving that the victim does not accept — nor does the law allow — such involuntary numbering or classification. While tax collection is not a popular function, without the terror scam all current illegal functions of government could eventually cease.

We are authorized to inform you that no IRS sleeper cell will receive public credit for any terror threat until you first affix your name, IRS terrorist badge number, and signature to the threat, and we do not respond to each terror threat individually.

If you wish to request a terrorist confession hearing, affix your name and signature to any future extortion threats, or simply call BR-549. Even if you request a hearing, please note that per Texas statutes listed below, we may still file criminal fraud charges against you in Texas should you elect to file a 'Notice of Federal Tax Lien' in Texas county records.

WHAT YOU SHOULD DO

- Read our notarized Affidavit of Material Facts (attached, sent certified mail) and understand that it shall stand in the record as un-rebutted statement of fact except as specifically refuted by you for the record;
- Read A Tax Honesty Primer (IRC and IRM sections, SCOTUS rulings, jury verdicts) attached, demonstrating that your jig is up;
- Read Texas Government Code 51.901 (Fraudulent Liens) to see that since you have no abstract of judgment and no agreement signed by me, if you should file a 'Notice of Federal Tax Lien', it will constitute criminal fraud in Texas;
- Read Texas Penal Code 32.48 to understand that each threat you have made or shall make to me, purporting to be a legal ruling or process, will constitute a separate criminal act of fraud under Texas law;
- Read Texas Penal Code 32.49 to understand that should you ever file such a document and refuse to remove it from county records when demanded to do so, you are "presumed to have had the intent to harm or defraud..."
- You should seek work outside the state-sponsored terror business.

We look forward to hearing from you immediately, and hope to assist you in fulfilling your responsibility as a reforming terrorist.
