Id. at 115, 117 S.Ct. 1114. "If the actor's tortious conduct creates a risk that the other will bear an unreasonable risk of harm,

the risk is borne by the actor under the principle of equitable indemnity." Id. at 118, 117 S.Ct. 1114. Based on the facts in that case, the Court found that the stevedore's breach of the duty to ensure a safe place to work gave rise to a claim of equitable indemnity. Id. at 119, 117 S.Ct. 1114. In an earlier case, the Court applied the rule of indemnity to an employer, finding that "the shipowner is entitled to shift its losses for the unseaworthiness of the ship to the stevedoring contractor." *Scindia Steam Navigation Co. v. De Los Santos*, 451 U.S. 156, 166, 101 S.Ct. 1614, 68 L.Ed.2d 1 (1981). There, the vessel owner sought indemnification from the stevedoring contractor who had a duty to take reasonable steps to ensure that the ship was safe for use. Id. The Supreme Court noted that the stevedore's breach of that duty was attributable to the stevedore, not the vessel owner. The Court concluded that the contract did not allow for the party which negligently breached the contract to shift its liability to the other party. Id. at 167-68, 101 S.Ct. 1614. Here, the jury found that Isogon failed to comply with the applicable standards of care of a common carrier. In contrast to the facts in Sc 2d92ce491b
