In a standard service agreement, what does it say about the "fee for representation" (if there is one)? Are they standard, or they could be different depending on the circumstances? Does it give guidelines? For example, I often get rather annoyed by things like these (from a standard

contract I have seen): You pay nothing for legal fees and costs until you collect at least one from the other side. That seems to be a fairly standard tactic, but I want to know the details. Do I need to worry about the truth of this? If I'm on a contract, do I need to say something like "in no event may we represent ourselves"? A: The Service Agreement that you are using is a contract between the client and their lawyer, not the lawyer and his or her insurance

company. From my understanding, the above is the basic law that must be followed by a lawyer. Any lawyer can take on the case, and provide legal services for free, but they are not allowed to make any money off of it. They can not charge the client more money than the client pays them. In this way, they are being a professional. A: I have had contracts (not so standard) that stated something like: X shall be paid by Y and Y shall be fully
