When installing Photoshop, you can decide whether to use it as an application or as a plug-in or module. To use Photoshop as a standalone application, download it to your computer and then run the program. To use Photoshop as a plug-in or module, download it and then run it via a separate plug-in viewer application, usually called a plug-in viewer. Your choice of using Photoshop as a standalone application or as a plug-in or module has nothing to do with which version of Photoshop you install. This choice comes from when you download Photoshop — the version is generally included with the program, and the program version may or may not include the plug-in or module. Figure 5-1 shows the interface of Photoshop CS5. As you can see, Photoshop CS5 has three major areas: **Figure 5-1:** Create and manipulate images with the tools in the left, right, and bottom areas of the Photoshop workspace. * The left side of Figure 5-1 is the main editing area of the program. Norton was ordered to be committed to the Department of Mental Health for inpatient treatment on March 8, 1988. The commitment was based on Norton's voluntary admission on June 16, 1987, and a petition filed on October 20, 1987, that alleged that Norton suffered from a mental disease or defect and that he had been previously committed to the Department of Mental Health on July 20, 1987. After a trial on March 9, 1988, the Circuit Court of Madison County ordered Norton's recommitment. *1222 The issue presented for review is whether Norton's commitment and recommitment are invalid under Ala.Code 1975, §§ 12-15-60 and 12-15-64. We conclude that the commitment and recommitment are valid and affirm. The case began on June 16, 1987, when Norton was admitted to Huntsville Hospital after telling hospital personnel that he had been "driving crazy." Norton was released on June 24, and was committed to the Madison County Mental Health Center for a period not to exceed 60 days. On July 15, the center filed a petition seeking to have Norton committed to the center for inpatient treatment. The petition was taken up on August 4 and the circuit court ordered Norton committed to the center for inpatient treatment. Norton was committed again on October 20, 1987, after he was hospitalized at Northport following an episode where he was yelling and causing a disturbance. At that time the district attorney of Madison County filed a petition in the circuit court seeking Norton's commitment to the center for inpatient treatment. Norton waived jury trial and the petition was tried to the court that evening. After a hearing on October 20, the court ordered Norton committed to the center for inpatient treatment. The order and commitment was entered on October 24, 1987. Norton had been hospitalized three times and had been released each time. He had also been hospitalized more than once before the first commitment; however, none of the previous commitments had resulted in a commitment.

Q: Any way to trim proportions of the text in the label of a tabbar? I want to have a special layout of the tabbar with controls at the right side, for example, not showing the whole tabbar label. The interesting thing is that the controls (for example, edit text) is very big and almost cover the left label. Is any way to trim these proportions? A: You can use the views provided in UIKit. However, we are not faced with that question in the case at bar. We agree with petitioner that there can be but one sentence for a violation of a statute of this nature, and that the language of the statute is mandatory and the only sentence which can be pronounced. It is not necessary for us to determine the question of whether failure to comply with the provisions of the statute may be construed as a misdemeanor or a non-criminal offense. It is sufficient to say that in the case at bar the language of the statute is mandatory and it is beyond the power of the court to pronounce a sentence for a misdemeanor of the second degree. The term of imprisonment under § 486(2) must be reduced to the maximum allowed by the Criminal Code of Procedure for the offense of assault with intent to murder (§ 449(2), F.S.A.) which is one year, and the judgment should be so modified.
