Mike Pence signed the Religious Freedom Restoration Act into law, the NBA and its players have joined Hillary Clinton in condemning the move. As more and more people watch the Indiana men's basketball team sweat it out in Kansas City, it's becoming increasingly clear that the country as a whole has lost its mind. NBA Commissioner Adam Silver said that the league has no intention of changing its position on anti-discrimination laws. He was specifically addressing a report from a sports executive who said that the league would "personally" consider changing its stance if players or coaches were fined \$100,000 for wearing jerseys with racial inscriptions. "For us, it is not about a team being black or white, it is about the NBA being an American league and we are proud of that identity," he said. "We also support the First Amendment and respect everyone's right to express their views." As for the Indiana law, Silver said that it could be used by those who discriminate against LGBT people or those seeking to discriminate against black Americans. He also expressed concern for the First Amendment rights of those who support the law or others who might be subject to punishment for their public statements. That is not something we condone and we have done our best to ensure that all of our employees are comfortable in their jobs
