Basic Window The basic window (see Figure 1.2), shown at the top of the workspace, is the place where you manage the image(s) that you are working on. The window appears when you open a new image, open an image and place it in a new window, copy an image to a new window, duplicate an image to a new window, or open an image that is already open in a new window. **Figure 1.2** The basic window

showing the history panel. If you aren't sure which image is the active image at any given time, you can use the F key shortcut to make the active image the current image. The F key opens the Find window, which gives you access to the current image, the images used to create the current image, and other images and settings. Although the basic window is the root of all operations in Photoshop, many editing functions are found in other locations in the workspace.

However, if you know Photoshop and want to save money, then this guide can help you to learn Photoshop Elements and use it to create stunning images like professional designers do. You will not find anywhere else a guide to learn Photoshop Elements like this one. Introduction to Photoshop Elements Photoshop is a complicated program, so Adobe designed Photoshop Elements to be a photo editor that is easy to

use. In Photoshop Elements, there are icons to perform many of the basic functions. For example, in Photoshop CS6 and below, you use the Edit > Pathfinder panel to apply feathering to images. In Photoshop Elements you need to go to Edit > Effects and then click on the Feather tool. Similarly, in Photoshop CS6 and below, if you want to create an image mask, you have to use the Select > Inverse feature. In Photoshop Elements, this tool is Invert. An advantage of Photoshop Elements is that many

tools are designed specifically for photo editing. However, there is a learning curve. Here are some tips for beginners who want to use Photoshop Elements to edit images. [Note] While the following tip may work well for some people, other advanced users may find this guide too basic. Tips for new users of Photoshop Elements Design work that requires specialized graphics skills is not a good candidate for Photoshop Elements. If you have a webcam that can record video, you

can use it as a tool to make still pictures (Canon camera or laptop). You can use a camera but it is not recommended because it may not work perfectly. [Note] Most computers do not have enough RAM for the video you record. You will have to use a laptop or desktop computer. You can use Windows or Macs. Make sure that the video quality is good. You will need at least 640 x 360 pixels. [Tip] If the video is 640 x 360 pixels, that means you can adjust the size to 1280 x 720 pixels,

because 640 pixels by 360 pixels by 3 pixels = 1280 pixels. However, use the Adjust Resolution feature to reduce the size. [Tips] When you download videos from the web, check that the video quality is good. Not all videos that you can download from YouTube or Vimeo will be of good quality.
